If approved, it is your responsibility to serve the summons on the person named in this form and give a copy of the summons to any other party in the matter, in accordance with the *State Administrative Tribunal Rules 2004*.

Once personal service has been effected, you must provide a completed *Declaration of Service* form to the Tribunal. This must be lodged via the [eCourts Portal](#) or in-person at the Tribunal's Registry.

### **Important notice to the person named in the Summons**

If you are seeking to set aside the summons or seeking an order to vary the terms of the summons, you must complete and file the '**Objection to Summons**' section below. If lodging via 'Upload Requested Items' on the [eCourts Portal](#), you will be prompted to upload the 'Document outlining objection reasons' as a separate attachment to the summons form.
