#### ELIGIBLE ENTITY

means an entity that has been granted legal aid or where the executive officer has directed is an eligible entity.

#### ELIGIBLE INDIVIDUAL

holds a current Centrelink cards; eg: health care card; health benefit card; a pensioner concession card; Commonwealth seniors health card; or

an individual who holds any other card issued by Centrelink or the Department of Veterans' Affairs of the Commonwealth that certifies entitlement to Commonwealth health concessions; or

an individual who is in receipt of a youth training allowance, or an AUSTUDY allowance; or

an individual who is in receipt of benefits under the Commonwealth student assistance scheme known as the ABSTUDY Scheme; or

an individual who has been granted legal aid; or

an individual who the executive officer has directed is an eligible individual.

#### ENTITY

does not include an individual.

#### INDIVIDUAL

does not include a public officer of the Commonwealth, of this State or any other State, or of any Territory acting in the course of his or her duties as such an officer.
